I. Approvals

A. Agenda

Motion to accept the agenda as amended to move Old Business after President's Report was approved. (Motion: R. Cermele; second: J. Hyland)

II. President's Report and Discussion – B. Bowen

- PSC co-sponsored successful CUNY & Race Forum, featuring information from Community Service Society report on changes in the racial composition of student admissions, particularly at the senior colleges, and preliminary findings on trends in race and gender distribution of faculty at CUNY and promotion and retention trends, from PSC study.
- Chancellor Goldstein will step down in early summer; William Kelly will be interim chancellor, PSC will be involved in search for permanent chancellor.
- Bargaining Update: PSC has achieved some important side agreements:
 - 1) Agreement to extend health insurance for eligible adjuncts through the Welfare Fund for 14 months, to 6/30/14. We succeeded in winning additional funds from the State and CUNY for adjunct health insurance, and, as part of the agreement, resolved some historic overload issues, incorporated some annual agreements permanently into the contract and secured \$250,000 for the Adjunct Professional Development Fund.
 - 2) Agreement on a 3-year pilot program on Phased Retirement for fulltime instructional staff who are members of the ORP (TIAA-CREF, etc.) and at least 65 years old. Faculty can phase at 50% of workload for 50% of salary for 1, 2 or 3 years; professional staff can phase at 80% for 80% pay for 6 months or 1 year. Inclusion of professional staff was an important victory; the PSC negotiating committee took the position that we would not agree to a Phased Retirement program unless professional staff and all fulltime faculty were included.
 - 3) All NYC municipal workers are working without a contract; Bowen proposed motion in the MLC to hold a protest rally to send a message to the current and future mayors about the need to pay the City workforce fairly. Rally on June 12th 4-6pm at City Hall Park to fight the false austerity mentality.
- NYSUT is holding a major rally in defense of public education on June 8th in Albany. PSC will support and join.
- Bowen reported on the successful Mayoral Forum on Tuesday, April 23rd.
- Pathways the Executive Council voted to hold a secret ballot referendum for all fulltime faculty on the question of No Confidence in Pathways, to be administered by AAA, May 9-31.

Motion that all PSC members be permitted to vote in referendum was defeated. (S. Persinger; Second: L. Dick)

Motion to approve Resolution of Support for Comprehensive Immigration Reform that Upholds Workers' Rights, Family Reunification and Provides for a Direct Path to Citizenship, including 1) editorial changes to add the principles listed in the last "Whereas" clause into the second "Resolved" clause and 2) adding a "Whereas" on CUNY's historic role in the education of immigrants was approved unanimously.
