I. Approvals

A. Agenda

II. President's Report and Discussion

- DACA Injunction Pres. Bowen reported that PSC participated in an amicus curiae
 brief that was part of a successful effort to secure a preliminary injunction by the
 Eastern District of New York barring the Trump administration from ending the DACA
 program nationwide while a lawsuit is pending. The union will continue to pull
 together resources to support sanctuary efforts.
- Rally on 2/24 Public sector unions and the CLC have called for a rally on Saturday, 2/24 at 11 am in Foley Square to protest the aims of the *Janus* case and show that there is a strong force opposed to dismantling public worker unions. PSC members will also join the protest at the steps of the Supreme Court on Monday morning, 2/26, the day of the oral arguments in *Janus*.
- Membership Blitz week of 2/26 PSC is planning a membership blitz the week of the Janus oral argument when the press's attention will be focused on the issue. Our membership goal for full-timers is 95% by June 30. We are at 94%. Current part-time membership is at 57%; our goal for June 30 is 75%. Delegates discussed plans for the Membership Blitz in chapter groupings.
 Since September 2017, PSC has collected nearly 8,000 blue recommitment cards. Members' recommitment on the new membership cards is important for the union's financial stability. The delegates must be at the center of this campaign. Building membership is part of the contract campaign and a fight for the survival of the labor movement.
- State Budget Campaign M. Fabricant Several lobby days coming up. PSC has a reasonable contingent going, but we need a large turnout from part-timers. Union activists will be reaching out to legislators from the city on the budget. The union is working with a group that is pushing very hard on alternative revenue sources such as closing the carried interest loophole, ending the rebate of the stock transfer tax, and expanding the millionaire's tax. The Working Families Party just endorsed three candidates challenging IDC candidates. April 24 is the PSC action day in Albany for \$7K per course for adjuncts.
- Report on NYSUT Resolutions N. Majumdar

The NYSUT RA will take place in late April in Buffalo. PSC has submitted resolutions on increased funding to cover the Excelsior scholarship, informed consent on ROTC, condemnation of America's "forever wars," and support of the PSC's campaign for \$7K per course for adjuncts.

B. Bowen reported that there have been victories in other grievances on adjunct three-year appointments.
