A surplus of \$104,000 was budgeted for twelve months. The financial statement shows an actual twelve-month surplus of \$3,284,000 when year-to-date expenditures are compared with year-to-date income. Over twelve months, we spent \$51,000 less than budgeted and received \$3,231,000 more income than anticipated (including State and City retro dues of \$2,540,000). This resulted in a favorable bottom line of \$3,180,000.

MOTION: To accept the August financial report. (Motion: I. DeLutro; second: A. Sherman) **APPROVED.**

• **Proposed 2017-18 PSC Annual Budget** – S. Persinger explained that the Supreme Court is expected to rule sometime between March and June that public-sector unions can no longer collect agency fees, and the proposed budget includes assumptions about the likely impact. Starting May 1, a reduction of about \$223,000/month is factored into the budget. That reduction can be decreased or eliminated through a successful membership drive. The PSC budget now has a budget-line for "Membership Campaign" because the union expects to be in a permanent membership drive in the future.

MOTION: To accept the proposed 2017-18 PSC Annual Budget (Motion: S. Sheidlower; second: L. Cohen)

PROPOSED AMENDMENT: To double the Chapter Budget line (line 37) from \$110,000 to \$220,000 (Motion: M. Kagan; second: D. Auslander) FAILED.

ORIGINAL MOTION APPROVED.

III. Election for Vacant EC Position

Nomination of Luke Elliott-Negri to fill the position of Part-Time College Officer (Motion: A. Vásquez; second: S. Sheidlower)

The chair called for any additional nominations. No additional nominations were made, and the body voted to close nominations.

MOTION: To elect Luke Elliott-Negri by acclamation (Motion: S. London; second: I. De Lutro) APPROVED. Luke Elliott-Negri elected by acclamation.

IV. **Discussion and Vote on Proposed Bargaining Demands -** B. Bowen reported that the PSC is using the term bargaining agenda to underscore the point that this is an integrated, comprehensive bargaining proposal. PSC is calling for real salary gains (5% increases per year), a breakthrough on adjunct salaries \$7K per course minimum), gains in salary and benefit equity for certain constituencies, consolidating gains made in previous rounds, and demanding protections proactively for coming technological, political and legal changes. The proposed bargaining agenda works against the management trend of increasing contingency and decreasing job security.

She emphasized that the proposed bargaining agenda represents an alternative to the austerity agenda supported by CUNY management, and that every proposed demand would contribute to the goal of enriching the education of CUNY students.

PROPOSED AMENDMENT: To add a demand for a seniority system for adjunct faculty (Motion: H. Clarke; severally seconded) FAILED.

PROPOSED AMENDMENT: To propose giving adjuncts the discretion not to apply for the three-year appointment. (Motion: P. Stemberg; severally seconded) FAILED

PROPOSED AMENDMENT: To propose changing the language on Graduate Assistantships to reflect the current practice of five years rather than three years. (Motion: M. Harakawa; severally seconded) FAILED

PROPOSED AMENDMENT: To change 28 (b) to apply to non-teaching adjuncts who worked at least 150 hours in six of the last 10 semesters (Motion: R. Squillacote; severally seconded) FAILED

PROPOSED AMENDMENT: To insert into the third line of 27(c) after "consideration of ways to" "ensure adequate compensation for all Ph.D. students" (Motion: I. Jabola-Carolus; severally seconded)

PROPOSED AMENDMENT TO THE AMENDMENT: Constitute the proposed amendment as 27 (f) (Motion: J. Gallagher; second: S. Sheidlower)

AMENDMENT WITHDRAWN

PROPOSED AMENDMENT: To change Article 24(b) so that step increases for adjuncts go into effect after six consecutive or nonconsecutive semesters, provide compensation for course cancellation less than two weeks before the course starts, and provide union reassigned time for part-timers (Motion: M. Kagan; severally seconded) FAILED.

MOTION: To accept the bargaining agenda recommended by the Executive Council. APPROVED
