II. President's Report and Discussion

- Thanks to all Delegates for attending tonight, in spite of the change of venue. Many Executive Council members spoke at the Brooklyn Borough hearing up the street and represented PSC perspectives on issues facing us very well.
- New Delegates Ian Hanson (York, Alternate)
- Cecelia McCall will receive the Sandra Feldman "Not for Ourselves Alone" award at the NYSUT RA in April.
- A number of important cases before the Supreme Court represent a direct attack on working people, including the Friedrichs case which is of the greatest concern to PSC.
 Justice Scalia's death means either there will be a tie vote and the Appeals court ruling against the plaintiffs will stand, or the Court could rule to have it reargued next session.
 There are other cases in the pipeline which can undermine working people's rights to build power, so we must continue to reach out to non-members to join the union.
- Contract Update CUNY filed for impasse in bargaining, and the Public Employee Relations Board (PERB) moved quickly to assign a mediator and schedule sessions. We all know the issue is money; we are close on many non-economic issues. If a mediator can help us make progress, fine, but, to be effective, a mediator has to be able to persuade CUNY, the City and particularly the State to provide adequate funding for a fair contract. PSC does not want to end up in a year of fact-finding which is the next step if mediation fails to achieve an agreement. That is why heightened activism around funding for CUNY in the State budget is so important.
- Strike Authorization Vote Organizing Now that the semester has started, one-on-one conversations about the strike authorization vote are ramping up. Hundreds of members have been trained to hold them. It's very important to submit contact sheets (which can be done online) about the conversations, as well as signatures on the Pledge. PSC will also be conducting a randomized phone survey of a sample of members through the NYSUT phone center.
- **PSC Secretary Nivedita Majumdar** reported that sign-on letters are available for 1) department chairs to express that they will not retaliate against workers who sign the Pledge to support the strike authorization vote, and 2) students who want to express support. She will send them to Delegates electronically.
- Legislative Report Mike Fabricant reported that delegates who want to participate in lobbying on Feb. 25th can go up to Albany and back in one day on the student buses.
 There is still room to participate in the Committee of 100 lobbying March 7 & 8.

Summary for the year-to-date (4 months)

Income: \$6,247,000 Expenses: \$6,088,000 Surplus: \$159,000

Year-to-date (3 months)

A \$30,000 deficit was budgeted for four months. The financial statement shows an actual four-month surplus of \$159,000. Over four months, the union spent \$187,000 less in expenses than budgeted and received \$2,000 more income than anticipated. This resulted in a favorable bottom line of \$189,000.
