II. President's Report

- We are facing an unusual convergence of contract and budget issues. The State
 has billions of dollars in one-time surplus funds from bank settlements, and PSC
 is pressing for an allocation to CUNY to cover retroactive salary increases for the
 PSC bargaining unit. Assembly Higher Education Committee Chair Deborah Glick
 has asked her colleagues to sign on to a letter supporting this, and the union has
 been asking members to fax letters to their representatives and Speaker
 Heastie.
- Contract Campaign Update: CUNY has not put an economic offer on the bargaining table with CUNY. The union has called on CUNY to move on both economic and non-economic issues. CUNY must move on other priority demands to address structural change. We have demanded that CUNY make measurable progress on our non-economic issues. The union's EC is meeting frequently to discuss needed actions.
 Bowen announced a PSC mass action on Tuesday, March 31, 5:30 – 7:00. The
 - Bowen announced a PSC mass action on Tuesday, March 31, 5:30 7:00. The message will be to urge CUNY to move on our contract and to move on our issues.
- State Budget Update: Bowen thanked the delegates who made trips to Albany on February 26 for lobby day and on March 2 for the rally against Governor Cuomo's education agenda.
 - A previous Act Now letter was circulated for members to ask their Assembly members to sign on to a letter for increased funding for Maintenance of Effort funding for CUNY. As a result of PSC members' calls and faxes, 43 Assembly members have signed on to that letter. Union members' efforts have made a difference in PSC's visibility among legislators. PSC has run two radio ads in Albany and NYC, and PSC principal officers have been in Albany every week since early February, meeting with legislators and delivering our petitions—with 11,000 signatures—to the Governor's Office.

Compared to a projected deficit of \$115,000, the financial statement shows a surplus of \$336,000 over three months. Over three months, PSC spent \$204,000 less than budgeted and received \$247,000 more income than anticipated.

B. City Budget – S. London

- S. London reported that he and M. Fabricant testified at the City Council that the \$13 million the Mayor allocated in his proposed budget for CUNY community colleges, although a slight increase from the previous year, is not enough. The City Council is expected to restore its current-year funding initiatives that the Mayor did not put into the budget.
