II. President's Report and Discussion

- Acknowledgement of City Council members B. Bowen thanked Inez Barron, Chair of
 the City Council Higher Education Committee, for joining PSC members on 3/24 in the
 civil disobedience action and also for ushering a resolution through the City Council in
 support of increased state funding for CUNY and a fair labor agreement.
 Councilmember Barron spoke briefly. City Council Member Daneek Miller was also
 arrested with PSC members, and will attend a future meeting.
- Acknowledgement of *Clarion* staff B. Bowen congratulated the *Clarion* staff on the multiple Metro New York Labor Communications Awards they won.
- Contract plans and Legislative Report B. Bowen reported on PSC's central role in successfully resisting the \$485-million cut in CUNY's funding that was included in the governor's executive budget. The proposed \$240 million for retroactive pay for CUNY workers remained on the table until the very end. PSC succeeded in elevating the contract funding issues and broadening the base of support, but, in the end, funding for back pay in the CUNY contracts was not included in the state budget. Bowen acknowledged the difficulty of achieving a fair contract under austerity budgets, but saif that the union's goal is to reach agreement on a contract with CUNY within the next six weeks, in time to resolve funding issues before the state legislature adjourns. The union bargaining team continues to work with the mediator appointed by PERB.
- Bowen also announced the governor's appointment of two new trustees—Bill
 Thompson as chair and Fernando Ferrer. Confirmation hearings are not yet scheduled.
- Strike Authorization/GOTV Planning The deadline for joining the list of pledge signers whose names will be made public is tomorrow. The names will be published the morning of May 2. Delegates cited the strike authorization vote taken by PSC in 1973.

A \$44,000 deficit was budgeted for six months. The financial statement shows an actual sixmonth surplus of \$49,000 when year to date expenditures are compared with year-to-date

income. Over six months, we spent \$171,000 less in expenses than budgeted and received \$79,000 less income than anticipated. This resulted in a favorable bottom line of \$92,000.
