I. Approvals

A. Agenda

II. President's Report and Discussion

- It has been a concentrated month working on funding for CUNY in the State budget. In addition to increased maintenance-of-effort (MOE) funding, CUNY needs increased community college base aid and increased senior college operating funding for more full-time faculty, adjunct pay parity and faculty workload restructuring. For the first time in the leadership's experience in Albany, public higher education is one of the two or three major issues, entirely because of the Governor's commitment to the Excelsior Scholarship. PSC's position has been clear: for more students, CUNY needs more investment. The next three weeks are critical; legislators have made some improvements in the one-house bills, but not enough. The union will be asking delegates to urge your members to call and send messages to legislators.
- PSC's work Resisting the Trump/Pence agenda continues: There are active Sanctuary campus efforts on several campuses. Union members joined a protest this week against the Puerto Rican Financial Control Board's actions. PSC will be building towards the May 1st nationwide moratorium on college campuses.
- Following CUNY's commitment in the contract to faculty workload restructuring, the
 union committee has continued to meet, and a meeting was held with at City Hall in
 support of CUNY's budget request for \$35M in City funding to implement it.
- Thank you to those who have worked hard planning tomorrow's Organizing Campaigns Retreat.
- The PSC Executive Council reviewed the QCC chapter's resolution concerning the NYS Inspector General's investigations at CUNY and advises that the DA not vote on it. To be clear, PSC vehemently opposes corruption and any wasting of money at CUNY.
- Legislative Report Mike Fabricant reported that PSC, NYSUT and CUNY Rising
 constituent groups have been lobbying hard in Albany for new State funding for
 investment in CUNY as well as to enhance affordability. Based on the one-house bills
 issued this week, we are confident we can make gains on some issues. We also need to
 press for expanded revenue by renewing and expanding the Millionaires' Tax. It is a
 long-term campaign, and the state will likely be hit hard by Trump's federal budget
 moves.

IV. Administrative Items

A. Treasurer's Report—S. Persinger

The Financial Statements for 12/16 and 1/16 could not be voted on for approval in the absence of a quorum, but Persinger noted that in January PSC received dues and fees on members' back pay at the senior colleges--\$1.8 milion—which was put into the union's reserve fund (\$1.7M into the Vanguard investment Fund and \$0.1M into the more liquid Amalgamated Bank account). Because PSC expenses are budgeted on an accrual basis, we are running a surplus because big expenditures in certain categories, like the Budget Campaign, have not appeared yet.

B. Executive Director's Report – D. Bell

Nominating petitions for chapter elections have been received and will be reviewed by the Elections Committee on Monday. There are contested elections in 2 chapters, Grad Center and Hunter, which will be administered by AAA. Ballots will be mailed April 3rd and are due back by 5:00 on April 27th. Ballots will be counted on April 28th. The report could not be voted on for approval.
