Year-to-date (7 months)

A \$50,000 deficit was budgeted for seven months. The financial statement shows an actual seven-month surplus of \$110,000 when year-to-date expenditures are compared with year-to-date income. Over seven months, we spent \$142,000 less than budgeted and received \$17,000 more income than anticipated. This resulted in a favorable bottom line of \$159,000.

III. President's Report and Discussion

- Strike Authorization Vote Outreach Delegates reported on their work to ensure a strong strike authorization vote. B. Bowen reported that votes will be counted on Thursday, May 12. The result will be announced as soon as the count is finished. P. Zwiebach reported on the impact of the Taylor Law on the Triborough Doctrine. B. Bowen thanked all activists who prepared videos and emails on why they are voting yes and thanked every person on staff for their work on the strike authorization vote.
- Bargaining Update B. Bowen reported that the bargaining team has been meeting frequently, and discussions are being held with the CUNY administration, sometimes in small groups, in an effort to reach an agreement in time for the legislature to pass a paybill before they adjourn on June 16.
- City Budget The Mayor's Executive budget increases overall funding for the community colleges by \$32 million. State-funded Base Aid adds \$17.6 million more this year. This means an overall increase of 5.4% to the community college budgets without having to raise tuition. The City has indicated that it will fund a PSC contract at a level commensurate with other City contracts.
- AFT Resolutions The AFT biennial convention is in July. Any proposed resolutions must be submitted to the Secretary by May 20. The principal officers are proposing several resolutions:

 end the garnishment of social security to pay student debt, 2) improve the AFT's presidential endorsement process, 3) call on candidate Clinton to break with the higher education policies of the past, break with the structural disinvestment, address the labor crisis in higher education, and address the need for students to have affordable and reliable access, and 4) support for students on hunger strike in India. The deadline for submitting resolutions to the AFT is June 6.

IV. Old Business

• Brooklyn College Worker Education Resolution

This resolution passed in the Executive Council contingent on the approval of the Brooklyn Chapter EC.

Therefore, be it resolved that the PSC demand that Brooklyn College fulfill its promise to support the planning of the proposed Masters' program in Economic Democracy and to restore the services long offered to working-class students at GCWE as an essential part of the college's public mission.
