Beyond Plastics Campaign

This <u>NY State-focused campaign</u> has already succeeded in ridding NY of single-use plastic bags but we have a ways to go to dramatically reduce harmful plastics from the waste stream. We are focusing on removing plastics from the CUNY waste stream by pushing for no plastic bottles in food services or vending machines and installing filtered water fountains in all CUNY buildings. Require TIAA to cease investing in Grabbed Agricultural Land

TIAA, the retirement system of most PSCers, is the world's largest holder of "agricultural land" investments--over 2 million acres worth \$10 Billion (out of the \$340 B they manage). Neutral sounding "agricultural land" is often "grabbed land" that has questionable legal status, destabilizes peasant and agricultural communities around the world and sets the stage for industrial agriculture and deforestation. Right now we are trying to figure out the exact situation, particularly with AFT's prior meeting with TIAA about this. Bring back an improved, robust, NYC Composting program

PSCers work with the #<u>SaveOurCompost</u> coalition to bring back composting, expand its accessibility to all communities, and make it mandatory. Budget cuts eliminated curbside pick-up and greatly reduced drop-off sites, leaving most New Yorkers with no way to recycle organic waste. If uncomposted, food waste, which constitutes 1/3rd of the city's waste stream, enters landfill, where it emits methane, a dangerous GHG many times more potent than CO2.Contact Jane Selden: janselo2000@yahoo.com.
