I. Approvals

A. Agenda

Motion to accept the agenda was approved. (Motion: H. Meltzer; second: A. Sherman)

B. Minutes

The June minutes were distributed; to be voted on in October.

II. President's Report and Discussion – Barbara Bowen

- Visual tribute to John Jay Chapter Chair Carl Williams, who died during the summer. In addition to PSC's \$500, delegates contributed \$532 for his children's scholarship fund.
 President Bowen thanked the John Jay Chapter Executive Committee for keeping the chapter together.
- Bowen announced that CC Officer Carl Lindskoog resigned this summer to accept a fulltime faculty position at Raritan Valley CC. Nominations will be taken and a vote held at the October DA.
- CUNY Bylaws Revision In response to intense pressure by members organized by the PSC, including a letter signed by nearly 1,000 faculty in a single afternoon, the CUNY Board of Trustees rescheduled the vote on proposed Bylaw revisions from June to September, and now again from September to November; PSC expressed serious concerns about some of the proposed revisions and about the lack of University-wide discussion of the changes.
- There is an agreement in principle with CUNY to make the Paid Parental Leave benefit permanent starting in 2012; still need to finalize the agreement.
- The CUNY Board approved a revised general education/transfer policy in June over substantial and vocal faculty opposition, a resolution of opposition from the University Faculty Senate and more than resolutions from campuses and departments across the University. The PSC is preparing to file litigation against the University's action.
- The report on this summer's research on the impact of budget cuts at the department level, including non-reappointment of adjuncts, will be made at the October DA.
- Upcoming events: The first Labor Goes to the Movies of the year on Friday; PSC-sponsored conference on Defending Public Higher Education on 10/7 at Grad Center;
 Defending the Social Safety Net Forum on 10/25 sponsored by PSC Retirees Chapter;
 Forum to announce preliminary findings from CUNY & Race research project in Nov. or Dec.
- Collective Bargaining Update:
 - Continuing to work on various side agreements like continuation of payroll agreement (which included 15 weeks of pay for adjuncts), continuing paid parental leave benefit, various calendar agreements.
 - There has been very little movement and no financial offer from CUNY.
 Bowen discussed relevant negotiations of other public-employee unions in
 New York City and State, and the union's collective bargaining strategy in the current political moment.

- PSC is continuing to build a coalition to demand that the richest 3% of New York taxpayers not receive a tax break in December. Bowen discussed the relation between the State's budget deficit for next year, which could be resolved by continuing "the millionaires' tax," and the demand for layoffs and concessionary contracts.
- The Adjunct Health Insurance Campaign is a key component of the PSC contract campaign, one we cannot lose; ensuring health insurance for eligible adjuncts takes on the heart of the labor contradiction in higher education where there are increasing numbers of adjuncts teaching more and more courses with inadequate benefits. After the demonstration on September 26 at the Board meeting, and organizing activities on the campuses in Oct., we will be back at the BOT hearing Nov. 21st maintaining the pressure on CUNY to ensure ongoing funding of adjunct health insurance.

PSC received less income than projected, but spent less than projected, particularly because some staff positions were unfilled and because of adjustments in the reimbursement formula the PSC negotiated with NYSUT.

IV. Reports and Action Items

M. Neimark, Chair of Elections Committee discussed proposed revisions to PSC Election Rules that had been mailed to Delegates and received comments from Delegates.

Motion made to amend Article III 2.d. (Motion: R. Yarmish; second: J. Gallagher) was initially ruled out of order. Motion to consider the amendment at the next DA was tabled. (Motion: J. Gallagher; second: I. DeLutro).

Motion to accept revised Election Rules with minor amendments in language suggested from delegates was approved with no dissenting votes. (Motion: M. Neimark on behalf of Elections Committee)

V. Old Business None.

VI. New Business

In response to recommendations by the PSC Legislation Committee and the PSC Solidarity Committees, the Executive Council voted to recommend affiliation with the Working Families Party. First V.P. Steve London introduced Dan Cantor, WFP Executive Director, who presented the WFP's history and electoral accomplishments and how it works.

Delegates raised questions and comments. There will be further discussion and a vote on whether or not to affiliate at the October DA.

VII. Treasurer's Report - Part II - Proposed PSC Budget 2011/12 - M. Fabricant

- There will be a budget review meeting before the next DA; at the next DA, Delegates will vote on the proposed budget.
- Last year, PSC projected 5% growth; this year only 3% growth.
- The budget reflects the union's political priorities, such as support for campaigns for increased funding for CUNY, for a strong collective bargaining agreement, for funding of adjunct health insurance, for defense of our members' rights and responses to their needs.
- It also reflects areas of growth and new initiatives.
- Increased expenses this year: the cost of university-wide elections, an intense contract campaign and work related to new space needed for additional staff, among other increases.
