What follows is a brief description of our members September efforts.

Public Ownership of Power Production

At our EJWG September 21 meeting, Professor Ashley Dawson, (College of Staten Island) reviewed the history and current movements for public power ownership and emphasized that the NY campaign is very exciting and everyone should be involved. Public Power organizer Jake Head, a graduate student at the CUNY School of Labor and Urban Studies, reported that state legislation is nearing completion for introduction in January, so lobbying efforts with legislators will begin after the Nov. elections. In addition to welcoming volunteers to contact their own legislators and key leaders, the campaign seeks expertise on labor, union, and prevailing wages in legislation. City-Wide Green Recovery Platform -Climate Works for All

The Climate Works 4 All Platform would create 100,000 good green jobs in NYC as a central part of the economic, health and racial justice recovery. The platform was successfully launched on Sept. 24. Plastic Pollution

Our representatives attend the Sept 24 meeting of Beyond Plastics. Founder Judith Enck reported that NJ legislators had approved the nation's first ban on both plastic and paper bags. It also includes a ban on polystyrene containers and requires food establishments to provide plastic straws only on request. The law would go into effect in eighteen months if signed. If you live in New Jersey, please contact **Gov. Phil Murphy** by phone or e-mail and urge him to sign the bill. His phone number 609-292-6000 and his

If you live in NYC, call NYC Council Speaker Johnson and urge him to bring to the floor a vote on the Ban Plastics Straw bill (intro 936).

Three New York City Congress members have not yet signed on to <u>Break Free From Plastic Pollution</u> <u>Act</u>: **Max Rose, Hakim Jeffries, and Alexandria Ocasio-Cortes.** If you are a constituent, please contact your representative and urge them to support this groundbreaking legislation. The fight to save the Kingsborough Community College (KCC) Urban Farm is part of the broader Free CUNY movement. The farm contributes to the alleviation of food insecurity which effects approximately 48% of KCC students. Advocates' goals include: Guaranteed paid employment for staff throughout the 2020-2021 year; employment of work/study and student aides each semester; guarantees needed for a safe work environment and inclusion of the farm in a 5 year priority plan that is currently under consideration. Divest NY State Public Pension Funds from Fossil Fuels

The EJWG works with <u>DivestNY</u> to get the State to divest from public pensions its over \$14B holdings in fossil fuels. Negotiations with NY State Comptroller **DiNapoli** on divestment is advancing. We are close to majorities in both the Senate and Assembly to require this divestment. We are particularly hopeful that the new class of state legislators will be adding a more progressive voice in January. We'll hold a press conference on divestment with our legislators after the Nov. elections.
