#### I. Approvals

## A. Agenda

#### II. President's Report and Discussion – B. Bowen

- Pres. Bowen thanked all those who came to the September 30 rally at the Board of Trustees
  and showed pictures from the event. PSC delivered a strong message on Pathways and the
  contract.
- Chapter Campaigns
- NYC Tech Workload R. Cermele, chair of the NYC Tech Chapter, reported on the successful two-year campaign to reduce the faculty workload to an average of 21 hours per year, the same as all other senior colleges in the CUNY system. The campaign involved a petition, which 85% of the faculty signed, a "No More 24" bake sale, and emails to the President.
   -Bronx Community College had a successful multi-year campaign to increase capital funding in order to address severe problems with the physical plant.
- Bargaining All municipal workers in the city are without a contract. CUNY has shown a
  willingness to negotiate on issues such as PSC/CUNY grants, and PSC will press to begin
  negotiations on non-economic issues like adjunct job security, HEO promotion and
  educational technology.
- HEO/CLT Timesheets PSC is engaged in a CUNYwide campaign to make the new HEO/CLT timesheets professional, transparent, fair and equitable.
- EC actions:
  - -Passed resolution in support of Greek teachers and public employees fighting austerity, -Passed resolution in support of fast-food workers,
  - -Passed a motion to form a committee on militarization at CUNY. Please email ideas to Ida Cheng (icheng@pscmail.org).
  - -Passed a motion to create a committee on teacher education.
- Student Summit PSC will host an activist student summit on October 19. The focus is on creating a space for students to raise their own issues and find ways to work together.
- Campus Equity Week An international week of events to raise awareness about the need
  for adjunct equity. This year PSC is collecting stories from adjuncts on the effects of job
  insecurity. It is the last week of October.
- PSC is hosting COCAL, the international Coalition on Contingent and Adjunct Labor next summer.
- Bill de Blasio endorsement CUNY is increasingly prominent in Bill de Blasio's campaign. He is promoting new funding streams for CUNY.

Monthly Financial Report – August

Summary of Financial Report for August 2013

Income: \$1,673,000 Expenses: \$1,537,000 Surplus: \$135,000

A deficit of \$185,000 was budgeted for twelve months. The financial statement shows an actual twelve-month deficit of 288,000 when year to date expenditures are compared with year to date income. Over twelve months, we spent \$26,000 more expenses than budgeted and received \$77,000 less income than anticipated.

Proposed 2013-2014 PSC Budget

The proposed 2013-2014 budget has been approved by the EC. It was reviewed in detail at the September DA. The union has projected 4% growth in income and a 4% increase in the dues owed to affiliates. The projected deficit is \$349,000. Money from the union's reserves—which have generally been added to over the past decade—will cover the deficit.
